





In the beginning... 2012

- ARRA Energy Efficiency Conservation Block Grant (EECBG) program was ending
- Grant funds were diminishing
- Needs of local governments were great
 - High Utility Bills
 - Deferred Maintenance
 - Aging and Failing Infrastructure
 - Lack of Understanding that energy costs could be controlled...



Local Government Energy Retrofit Program begins

- Kentucky Energy Office applied for and received federal DOE Competitive Grant --
- Partners on the Application included:
 - Department for Local Government
 - Kentucky ESC Chapter
- \$715,000
- 3 years
- Designed to assist local governments in exploring/using ESPC
 - Education/Outreach
 - Technical Assistance
 - Partner in Understanding Process

Partnerships were cemented...

- University of Kentucky Center for Applied Energy Research selected after competitive RFP to provide
 - Boots on the Ground
 - Assistance for Local Governments
 - Assist in development of template documents
- Kentucky ESC Chapter instrumental in early days of education for local officials
 - Area Development Districts
 - Kentucky's Lt. Governor Champion
 - Planning Organizations
 - Kentucky League of Cities and Association of County Governments conferences

Since LGERP began at the end of 2012

- 23 local government ESPCs have been completed
 - Prior to that time 4 local government ESPCs had been completed in Kentucky
- Over \$82.3 million has been invested.
- Average contract approximately \$3.5 million
 - 11 City
 - 9 County
 - 3 combined city/county



Technical Assistance Component

- Has helped varying sizes of city and county governments complete 7 ESPCs.
- Totaling over \$18 million
- Average Contract is about \$2.25 million
- Range from \$1 \$3 million
 - Small
 - Interlocal Agreements
- Not all local governments followed through.
 - Local board, city commission or county fiscal court did not approve.
 - Elected officials losing primary or election or deferring.
 - Cash Flow was too close.



Progress Continues...

- Original Grant ran from 2012-2016 (one year extension from U.S. DOE)
- State Environmental Mitigation Penalty Fund allowed State Energy Office to continue the program through June 2018
- Kentucky Department for Local Government is continuing project.
- Currently--
 - 6 Projects in ESCO selection have occurred.
 - 3 RFPs under review by local governments.
 - 5 RFPs being developed.

Keys to our Success

- Cooperation among state agencies and partners
- Being associated with the Kentucky Department for Local Government and the University of Kentucky opens doors.
- Using local officials for peer to peer exchange. Case Studies
- Small Grants to locals
- Leveraging resources and building on the other sector ESPC success in state government, K-12 schools, and public universities.





Keys to our Success

- Leveraging resources and building on the other sector ESPC success in state government, K-12 schools, and public universities.
- Being visible
- Buy In from ESCOs
- Maintain communications
- Emphasize free and neutral
- Facetime (not electronic communications)





Overcoming Hurdles

- Getting smaller jurisdictions to work on inter-local agreements
- Demonstrating an ESPC is a viable option
- Upcoming elections
